


The successful Vendor may not subcontract any part of the work covered by this contract. Any subcontractor must be disclosed as part of the bid submission for review by the Company prior to final selection.


The Company reserves the right to cancel any contract if and when it feels services rendered are unsatisfactory. The City shall be the sole judge in this matter.




